



2. As per the order of the Vice Chancellor an inspection was conducted in the college for verifying the facilities available for starting the course. The Inspection Commission vide paper read (2) above, verified the infrastructural and instructional facilities available in the college and recommended to start B Sc Computer Science programme with an intake of 24 seats in the current Academic Year . The Commission also recommended to start M com with International Business with an intake of 20 students since Taxation is not offered by the University as an elective.
3. The commission further recommended that (i) For BSc Computer Science, Library has to be furnished with books related to the Syllabus and more computers shall be provided , (ii) More books and journals relating to International Business shall be purchased for M Com.
4. The report of inspection was placed before the syndicate for consideration. The syndicate vide the paper read (4) above, resolved to grant provisional affiliation to Unaided Courses of B Sc Computer Science Programme & M Com International Business course in SES College, Sreechandapuram, Kannur during the academic year 2015-16 subject to the verification of bills and vouchers of purchase of books specified in the inspection Commission report.

1. Provisional Affiliation was granted to B Sc Computer Science (self financing) Programme with an intake of 24 students in SES College, Sreekandapuram for the academic year 2016-17 vide paper read (1) above. Provisional affiliation was granted subject to the production of compliance report with documentary proof regarding rectification of defects pointed out by the Inspection Commission.

2. The Hon'ble High Court of Kerala in its judgment in WP (C) 38955 of 2016 dated 08.12.2016 directed the University to pass appropriate orders on renewal of affiliation within a period of one month from the receipt of judgment vide paper read (2) above.

3. The Syndicate held on 23.12.2016 vide item No. 2016.619 resolved to defer the matter of granting affiliation and the syndicate held on 17.01.2017 resolved to grant affiliation for the year 2016-17 vide paper read (3 and 4) above.

4. The Principal vide paper read (5) above, has requested to grant Continuation of Provisional Affiliation for B Sc Computer Science Programme, alongwith other Programmes, during the academic year 2016-17 on remittance of the requisite fee. The Principal of the college has not furnished compliance report with supporting documents regarding rectification of shortcomings as insisted. Further, staff profile of faculty of self financing courses for 2016-17 has not been approved.

5. After considering the matter in detail, in compliance with the judgment of the Hon'ble High Court of Kerala, sanction has been accorded by the Vice-Chancellor for Continuation of Provisional Affiliation to B Sc Computer Science Programme (self financing) with an intake of 24 students during the academic year 2016-17 in SES College, Sreekandapuram subject to approval of staff profile of faculty of self financing courses and rectification of short comings pointed out by the Inspection Commission as insisted vide paper read (1) above.

6. The Continuation of Provisional Affiliation granted is subject to the Provisions in the Kannur University Act/ Statutes/Ordinance/ Rules/ Regulations and also the Rules and Regulations of the Government of Kerala in force from time to time in all matters related to the College.

1. The Principal, SES College, Sreekandapuram, Kannur submitted applications for additional courses of BA. English with Journalism (40) and B.Com (Computer Application) (50) during the academic year 2014-15 and for the courses M.Sc. Computer Science (20) and M.A. English (25) during the academic year 2015-16 vide paper read (1) above.

2. After conducting a Preliminary Inspection, vide paper read (2) above, recommendations were forwarded to the Government for sanctioning BA. English (30), B.Com Computer Application (35), M.A. English (15) and M.Sc. Computer Science (15) Courses/ Programmes in SES College, Sreekandapuram, Kannur during the academic year 2015-16.

3. The Government of Kerala, vide paper read (3) above, have granted No Objection Certificate for starting self financing courses of M.Sc. Computer Science (15), M.A. English (15), BA. English (30) and B.Com Computer Application (35) in SES College, Sreekandapuram, Kannur during the academic year 2016-17.

4. An Inspection was conducted in the College on 08.06.2017 and the Commission observed many shortcomings with regard to the starting of the above Courses/ Programmes vide paper read (4) above. The Syndicate held on 09.06.2017 vide paper read (5) above considered the report and resolved to grant affiliation to the above said courses during the academic year 2018-19 after rectifying the defects pointed out by the Commission as detailed below.

- a) For B.A. English, no Class room for the Course is found. Library stocked with popular fictions only. Books related to literature were not found. No separate staff room found. Staff Profile required for the Course was not provided.
- b) For M.A. English Course, no class rooms for running the course. No separate library. Books related to literature were not found. No reference book or journals found.
- c) For M.Sc. Computer Science, no Computer Lab facilities. No class rooms available for the course. Library is insufficient. Books related to M.Sc. Computer Science were not there. Reference books and journals were absent.
- d) For B.Com, no lab facilities and class rooms required for the course. No sufficient books in the Library. No separate staff room facility for the Department.
- e) Office, Library, Reading Room, Principals Room, Professors Room, Department Staff Room, Staff common Room, Common Room for both men and women students and tiffin rooms for the students were verified by the Inspection Commission and all these are found absent and hence unsatisfactory. The Library, Staff Room, Computer Lab are without required space.
- f) The Inspection Commission could not find any facility at Library and Reading Room.
- g) No relevant books are found for the required course as stipulated by the Statutes.
- h) The self financing courses are proposed to be set in a building which is situated in the same aided campus area.
- i) The infrastructural and instructional facilities are very poor and meager for running the new courses. It is against the provisions stipulated in the Kannur University Statutes.

5. In view of the decision of the University, the Manager, SES College, Sreekandapuram approached the Hon'ble High Court seeking affiliation to the Courses/ Programmes during 2017-18.

6. The Hon'ble High Court of Kerala in its judgment dated 30.08.2017 in W P (C) No. 22127 of 2017 among other things directed the University to grant Provisional Affiliation to the petitioner to start the Courses for the ensuing academic year 2017-18 with conditions incorporated there to, to rectify the defects pointed out by the University. The Hon'ble High Court has extended the time for completing the admission process upto 20.09.2017.

7. As per the papers read (8) above, the Manager SES College, Sreekanadapuram and the Principal of the college have requested to grant Provisional Affiliation to the above said Courses remitting the required fee.

8. Considering the matter in detail sanction has been accorded by the Vice-Chancellor to comply with the order of the Hon'ble High Court in W P (C) No. 22127/2017 dated 30.08.2017, thereby granting conditional Provisional Affiliation to M.Sc. Computer Science (15), M.A. English (15), BA. English (30) and B.Com Computer Application (35) Courses/ Programmes in S E S College, Sreekanadapuram for the academic year 2017-18.

9. Provisional Affiliation granted is subject to the Provisions in the Kannur University Act/ Statutes/ Rules/ Regulations and also the Rules and Regulations of the Government of Kerala in force from time to time in all matters related to the College.

10. The College authorities shall follow the common course and complementary course as per the scheme and syllabus approved by the University applicable to the programme.

11. The Principal of the College shall forward a copy of the No Objection Certificate renewed for the courses for the academic year 2017-18 from the Government of Kerala.

Faisal (Head, Dept. of Management Studies) and the Inspection was conducted on 12/03/2014. 
