- Smt Nasreena P K, Puthukkudi House, Pathayakkunnu (PO), Thalassery (Via), Kannur Dt, 670 691 had submitted application for Entrance Test/ Course work leading to Ph.D programme as per the Notification read as first above. She, being a regular teacher of Aided College, has been exempted from taking Entrance Test for Ph.D Programmme.
- Smt Nasreena P K has passed her M.A Degree in History from Kannur University with 64.5% marks in aggregate.
- 3. The UGC, from July 2009 onwards, made it mandatory to do Coursework as a component of Ph.D programme. The University has revised its regulations for Ph.D programme and the award of Degree of Doctor of Philosophy, in compliance with 'UGC Regulations on minimum standards and procedure for the award of Ph.D Degree, regulations 2009' named as "Regulations for Ph.D Registration and award of Degree of Doctor of Philosophy-2011". As per said regulations, candidates are eligible for Ph.D registration only on the successful completion of the Coursework.
- 4. Smt Nasreena P K, joined the Coursework Centre at Department of History and Heritage Studies, Kannur University, Mangattuparamba on 01.12.2017 for doing coursework as a part of Ph.D programme. As per clause 4.2 of the "Regulations for Ph.D Registration and award of Degree of Doctor of Philosophy-2011", the date of registration to Ph.D programme will be the date on which the candidate joins for Coursework at the Coursework Centre.
- The Coursework Co-ordinator has issued the Coursework Completion Certificate in respect of Smt Nasreena P K stating that she has successfully completed the coursework with required attendance.
- 6. Smt Nasreena P K has submitted application for registration to part time Ph.D programme in History under the guidance of Dr. G PremKumar with Kannur University Central Library as the Research Centre.
- Smt Nasreena P K working as Assistant Professor at S.E.S College , Sreekandapuram, has produced No Objection Certificate , from the Manager ,SES College ,Sreekandapuram.
- 8. She has remitted the requisite fee for registration in to the University fund and has produced origins challan receipt.(Ch dtd,27/04/2018 of SBI,Kannur University,Mangattuparamba).

- 9. The Departmental Doctoral Committee met on 09.05.2018 scrutinized the application and Synopsis of the Research work submitted by Smt Nasreena P K has been approved for doctoral research with a change of title as "Technological Expertise and social life of Mappila Khalasis in Malabar". The candidate has been directed to submit the revised synopsis with the title given above through the chairman of the doctoral committee and as such she resubmitted it.
- As per the U.O No.Acad E3/10218/R.Eng/2015 dt 27.02.2018 ,Syndicate resolution No.2018.008 dt 09.02.2018 ,there will be no Preliminary Qualifying Examination w.e.f 01.12.2017 ie., the 2017-18 coursework batch onwards.
- 11. As per the order of Hon'ble Vice Chancellor, Smt Nasreena P K is permitted to continue her research work at kannur University Central Library as the research centre under the guidance of Dr G Prem Kumar till Government Brennen College becomes an Intra University Centre for Convergent Studies in Human Sciences.
- 12. The following orders are issued on the matter as approved by the Vice chancellor.
- (i) Smt Nasreena P K, Puthukkudi House, Pathayakkunnu (PO), Thalassery (Via), Kannur Dt, 670 691 is granted provisional registration to Part time Ph.D programme in History under the guidance of Dr G PremKumar with Kannur University Central Library as the Research Centre on the topic "Technological Expertise and social life of Mappila Khalasis in Malabar".
- (ii) Smt Nasreena P K is directed to report for research at the above research centre in presence of the Supervising Teacher and Head of the Research centre, within one month from the date of this order, failing which the registration now granted will be cancelled. The joining report, mentioning the actual date of joining, signed by the supervising Teacher shall be forwarded to the university by the Head of the Research Centre.
- (iii) Research leading to Ph.D programme by Smt Nasreena P K will be governed by the 'Regulations for Ph.D Registration and award of the Degree of Doctor of Philosophy -2011' and the guidelines prescribed for Ph.D Programme as per the said Regulations amended from time to time.
- (iv) The registration date of Ph.D programme in respect of Smt Nasreena P K is 01.12.2017, i.e the date of joining the Coursework. The registration now granted will become absolute only on qualifying in the Coursework Examination of Paper I and II conducted by the Course Coordinator.
- (v) Smt Nasreena P K being a Part time research scholar is eligible to submit the Ph.D final thesis after a minimum period of three years from the date of registration and before completion of six years, (After 01.12.2020, but not later than 30.11.2023).
- (vi) Smt Nasreena P K, after her joining at the Research Centre shall spend a period of 60 days per year for the Research work, being a part time scholar. Certificate to the effect that the candidate has attended the institution, for the period, signed by the Research Guide and Head of the Research Centre shall be produced with the thesis.
- (vii) The Supervising Teacher shall constantly monitor the research activities of Smt Nasreena P K from the Research Centre concerned and report the progress of her Research Work to the University, once in six months, failing which her registration is liable to be cancelled.
- (viii) The Head of the Research Centre shall forward the details of fee collected from the scholar with effect from the date of joining.
- (ix) A research supervisor /Co-supervisor is a professor, cannot guide more than eight Ph D scholars. An Associate professor can guide 6 Ph D scholars and an Assistant professor can guide 4 Ph D scholars.
- (x) Smt Nasreena P K has to present a pre submission seminar and publish research paper before the submission of the final thesis as provided in the Regulations for Ph.D Registration and award of the Degree of Doctor of Philosophy -2011.
- (xi) All other terms and conditions prescribed by the University from time to time will be applicable to the Research work of Smt Nasreena P K.The research scholar shall strictly comply with the rules and regulation of the University.
