- 1. As per the reference read first above, Dr. Dominic Thomas, 'Pulickal House', Edat (P.O), Payyannur, Kannur 670 327 has applied for research guideship in Physical Education with Department of Studies in Physical Education, Kannur University as the centre for Research Guidance. He is working as Associate Professor in Physical Education, Payyannur College, Payyannur.
- 2. Dr. Dominic Thomas was awarded Ph.D. Degree in Physical Education in 1997 by the Jiwaji University, Gwalior vide the reference read second above.
- 3. As per the reference read third above, the revised guidelines granting research guideship and status of research centre was implemented in the University with effect from 22-06-2011.
- 4. As per the reference read fourth above, criteria for granting research guideship in the guidelines was modified. As per the U.O. "The applicant for research guideship should have published at least two papers in the subject concerned after the award of the Degree of Doctor of Philosophy in the peer reviewed journal (s)".
- 5. The application for research guideship submitted by Dr. Dominic Thomas has been processed as per the revised guidelines, granting guideship and the application is in order. His application has been recommended by the Chairman, Board of Studies. He has submitted all documents and remitted the requisite fee in the University fund.
- 6. The Vice Chancellor having considered the matter in detail has accorded sanction to grant research guideship to Dr. Dominic Thomas in the subject Physical Education with Department of Studies in Physical Education , Kannur University, as the centre for research guidance.
- 7. The Research guide will ensure that the research scholars under his/her guidance shall comply with the Regulations of the University and UGC regarding research.
- 8. The Research Guide shall follow the Rules, Regulations and Guidelines applicable and U. O issued by the University from time to time on the matter.
- 9. The Research Guide of Kannur University is not permitted to have more than eight research scholars under his/her guidance at a time including both the part-time and full-time research scholars in this University and other Universities.

- 10. The Research Guide of Kannur University should submit annual declaration on the total number of research scholars working under his/her guidance.
- 11. Teachers of the University Departments or Affiliated Colleges in the Government/ Aided Sectors, who are recognised as Research Guides by Kannur University are not permitted to register research scholars from other Universities/ Institutions without obtaining No Objection Certificate from this University.
- 12. The Research Guide is not permitted to supervise the research activities of any of him/her immediate relatives.
- 13. The Research Guide will intimate the University his/her transfer/retirement/relief of duties from the present institution in time.
- 14. The Research Guide shall regularly monitor the research activities of the research scholars working under his/her guidance and report the matter to the University once in six months in the case of part-time scholars and once in three months, in the case of full-time scholars.
- 15. The Research Guide is bound to follow the rules, regulations and guidelines applicable and issued by the University and UGC from time to time failing which the University reserves the right to cancel the research guideship granted to him/her.
- 16. The Research Guideship will automatically be cancelled, if no research scholars are registered under a Research Guide after four years from the date of recognition granted to him/her as a Research Guide.
- 17. If the Research Guide feels that Joint Supervision is necessary for the research work having inter-disciplinary/multi-disciplinary nature, the service of Co-guide may be made available, subject to the condition that the Research Guide has requested for the same, specifying the name of Co-guide and the Doctoral Committee approved the request.

 - iii. Joining report shall be signed by both Research Guide and Head of the Research Centre concerned and should contain entries regarding the date of reporting/joining of the candidate as a Research Scholar for Ph.D. programme before them.
 - iv. His Research Work shall be governed by the "Regulations for Ph.D. Registration and Award of degree of Doctor of Philosophy-2018" and the guidelines prescribed for Ph.D. Programme as per the said Regulations amended from time to time.
 - v. As per clause 4.1, Ph. D programme shall be for a minimum duration of three years, from the date of joining the research centre and a maximum of six years. Being Ph. D Research Scholar, Sri. Sajeesh K C shall submit his Ph.D. Final Thesis after a minimum period of three years and within a maximum period of six years from the date of registration.
 - vi. If the research scholar fails to implement these corrective measures, the Research Advisory Committee may recommend to the University with specific reason cancellation of the candidate's registration.
 - viii. A research supervisor/co supervisor, who is a Professor, shall guide not more than 8 Ph. D scholars. An Associate Professor can guide 6 Ph. D scholars and an Assistant Professor can guide 4 Ph. D scholars.

- ix. Sri. Sajeesh K C has to present a pre-submission seminar and publish research paper as provided for in the "Regulations for Ph.D. Registration and Award of Degree of Doctor of Philosophy-2018".
- x. All terms and conditions prescribed by the University from time to time will be applicable to the Research Work of the Research Scholar, in this regard. The research scholar shall strictly comply with the rules and regulation of the University.
